



## Hoteles City Express Announces the Opening of City Express Plus Guadalajara Providencia and City Express Plus Mazatlán, and the Mutual Agreement to Terminate City Express Plus Satélite’s Franchise Agreement (BMV:HCITY)

**Mexico City, February 1<sup>st</sup>, 2023 – Hoteles City Express, S.A.B. de C.V.** (“Hoteles City Express”) (BMV: HCITY), announces the opening of the 150-room City Express Plus Guadalajara Providencia Hotel, which is 100% owned by the Company, and the 130-room City Express Plus Mazatlán Hotel which will be under a management agreement. The Company also announces the mutually agreed termination of the franchise agreement for the City Express Plus Satélite hotel.

The City Express Plus Guadalajara Providencia hotel is located at Avenida Las Américas 1520 in the Providencia area of Guadalajara, Jalisco. The prominent commercial and financial hub is well known for its fine dining, recreation and sports complexes, contemporary events, and a wide array of corporate offices. The hotel was designed to accommodate both business and leisure travelers and is the Chain's fifth in Guadalajara and seventh in the state of Jalisco.

The City Express Plus Mazatlán hotel is located at Avenida del Palmar 2224 in Mazatlán, Sinaloa in one of the country's most attractive beach tourism destinations. The area has outstanding cultural and dining attractions, in addition to a wide range of tourist offerings for both leisure and business travelers. This is the Chain's second hotel in Mazatlán and fourth in the state of Sinaloa.

As of today, the Guadalajara and Mazatlán hotels will become part of the Hoteles City Express Chain, and the Satélite hotel will become an independent hotel and will no longer be a part of the inventory. This brings the current inventory of Hoteles City Express to 152 hotels and 17,487 rooms.
